Discussion: Kathy Lippert provided some information to the public regarding some topics that came up during the 5:00 p.m. Community Meeting. President Scoby urged the public to provide written testimony to their legislators regarding land transfer petitions.

Mr. Evans provided the following information --

- All school kitchens in the District have passed inspections.
- APS roof has not been replaced, SMS and SHS need a long-term plan for replacing roofs.
- SPED funding USD 113 KSDE is paying 546,980 out of the General Fund for SPED. To reach

92%, \$106,287 more is needed.

- LifeWise -- there are ongoing discussion of expanding the program into 6th grade, Juniors/Seniors taking college course on religious studies. Lifewise would like them to transition off-campus for these classes to get extra funding.
- The change from a 2-year lookback to 1 year lookback may be delayed until school year 25-26. The part of the bill to penalize districts who closed schools has been removed.
- IT update -- the district currently has
  Kajeet devices that families can check out,
  which are similar hotspots. There have been
  discussions about having internet capability on
  school buses. Our bus drivers are still on
  paper time sheets, and every mile of our
  transportation has to be accounted for on the
  18(E), CTE, Activity, route miles, over/under
  65 years old, etc.
