Board Member Jim Scoby arrived at the meeting at 6:17 PM.

Mr. Evans gave his Superintendent's report electronically this month and included a link on the agenda that was emailed to board members, staff and patrons. He included a construction update on the Axtell project, YTD financial information along with some other items of interest.
