### PETITION BY BOARD OF EDUCATION OF UNIFIED SCHOOL DISTRICT NO. 115 FOR TRANSFER OF TERRITORY

This Petition is made by the Board of Education of Unified School District No. 115, Marshall and Nemaha Counties, State of Kansas, to the Kansas State Board of Education on this 15th day of February, 2024. As the basis for this Petition, the petitioning board states:

1. This Petition is made under authority of K.S.A. 72-532.

2. Mediation was attempted under K.S.A. 72-530 but failed.

3. The State Board of Education is requested to transfer the territory described in the certified land description attached as **Exhibit A**, "LEGAL DESCRIPTIONS FOR DISTRICT BOUNDARY MODIFICATION BETWEEN UNIFIED SCHOOL DISTRICTS NO. 113 AND NO. 115" (hereinafter "Petitioned Area") from Unified School District No. 113, Marshall, Nemaha, Brown, and Jackson Counties, State of Kansas, to Unified School District No. 115. Marshall and Nemaha Counties, State of Kansas. The Petitioned Area is also shown on the attached map in **Exhibit B**.

4. The petitioning board is of the opinion that the transfer of territory requested in this Petition, if granted, would be consistent with the factors listed in subsection (d) of K.S.A. 72-532, as further described within **Exhibit** C – General Information.

5. No petition for the transfer of substantially the same territory as described above has been submitted to the State Board within two years of the date of this Petition.

6. The petitioning board of education has authorized its president to sign this petition on its behalf.

Additionally, if the transfer is not approved, the vast majority of students in the Petitioned Area will attend a district (USD 115) that does not receive transportation funding for transporting those

			students, necessitating USD 115 to allocate other budgeted moneys to transportation instead of expanding educational services.

28. Briefly describe how each of the factors listed in subsection (d) of K.S.A. 72-532 impacts the request for transfer of territory. (**Statutory factors listed in bold**, *Petitioner statements listed in italics*.)

K.S.A. 72-532(d) Prior to issuing an order, the state board shall consider the following:

# (1) City boundaries and the area within three miles surrounding any city with more than one district in the area;

Seneca is the county seat of Nemaha County and the District Headquarters of USD 115. The Petitioned Area is completely within Nemaha County. The Petitioned Area, including the city of Bern (site of the 2012 school closure), is closer in driving distance and time to Seneca, Kansas, than it is to Sabetha, Kansas, site of USD 113 District Office and attendance centers. Sabetha is a city in Nemaha and Brown Counties. None of the Petitioned Area is within Brown County. The City of Bern, Kansas is in Nemaha County and completely within the Petitioned Area.

(2) available capacity of districts involved in the territory transfer to serve existing or additional students;

USD 115 is already serving 75% of students in the Petitioned Area as out-of-district enrollees. This land transfer is sought to better reflect the clear enrollment trends, family preferences, and landowner preferences in the Petitioned Area.

In November 2022, USD 115 electors approved a \$24 million bond issue to expand capacity of its attendance centers in Seneca, Kansas. USD 115 is currently operating at capacity due to the influx in students from the Petitioned Area over the past several

years. Anticipated to be completed in August 2024, the infrastructure upgrade and expansion will accommodate additional students as more families chose to attend USD 115 due to regional practicalities.

## (3) condition and age of buildings and physical plant;

USD 115's November 2022 \$24 million bond issue has financed an extensive renovation and expansion project for its attendance centers in Seneca, Kansas, which is anticipated to be completed in August 2024.

The renovation and expansion project includes: 1) expanded early childhood and elementary school facilities, including classrooms, support space, cafeteria expansion, playground and parking expansion, and direct street access; 2) existing high school renovation, including classroom, restroom, locker room, tech building, band room, special education room renovation, as well as HVAC, fire alarm, mechanical systems, and site/sidewalk upgrades; and 3) new high school construction, including new classrooms, STEM facilities, secured main entry and office, and other site/sidewalk/access upgrades.

## (4) overall costs including renovation of existing buildings versus construction;

USD 115's November 2022 \$24 million bond issue has financed an extensive renovation and expansion project for its attendance centers in Seneca, Kansas, which is anticipated to be completed in August 2024. The infrastructure upgrade and expansion will accommodate additional students as more families chose to attend USD 115 due to regional practicalities.

### (5) cost of bussing;

As families from the Petitioned Area have enrolled out-of-district in USD 115, USD 115 has bussed the students in the Petitioned Area to Nemaha Central attendance centers, while receiving no transportation funding from the state. Upon transfer, USD 115 will be eligible for transportation funding as the home district of this area. USD 115 has purchase additional vehicles and busses to accommodate the transportation of its students, including out-of-district students in the Petitioned Area for whom the district does not receive transportation funding.

## (6) food service;

Upgrades to USD 115 attendance center cafeterias included in the \$24 million bond issue upgrades expected to be completed in August 2024 will enhance accommodation of the 75% of students in the Petitioned Area already attending USD 115.

## (7) administration and teachers;

USD 115 has accommodated the now 78 of 104 students living in the Petitioned Area for several years with existing staff resources. Transfer of the Petitioned Area to USD 115 would allow the district to derive ad valorem revenue from this area, ensuring that expanded local option budget revenues can support overall budget strategies that prioritize educational services provided by USD 115 administration and teachers.

# (8) areas of interest including access and distances for parents to travel to participate in student activities;

The vast majority of students residing in the Petitioned Area (75%) already attend USD 115, and those families share governmental, cultural, religious, recreational, economic, and other affinities with Nemaha County residents. The Nemaha County seat and USD 115 district and school facilities is Seneca, Kansas, and the Petitioned Area is closer in driving distance and time to Seneca, Kansas than to similar resources in Sabetha, Kansas, the site of USD 113 district and school headquarters. Additionally, residences in the Petitioned Area access Seneca, Kansas on more safe and direct routes compared to access to Sabetha, Kansas, given that Seneca is accessible by a well-maintained state highway, while the most direct route to Sabetha is accessed by a county road with no dividing lines. The parcels of the Petitioned Area closest to Sabetha are still equal in distance and time to Seneca, while the vast majority of parcels within the Petitioned Area are closer to Seneca.

# (9) matters of commerce, including regular shopping areas, meeting places, community activities and youth activities;

<u>Nemaha County Seat.</u> The Petitioned Area exists completely within the northern and eastern parts of Nemaha County, Kansas. The county seat of Nemaha County is Seneca, Kansas. Seneca, Kansas is also the location of the USD 115 District Office and attendance centers, including Nemaha Central High School, Nemaha Central Elementary and Middle School, and Marshall-Nemaha Special Education Co-op. As a result, the center for public and governmental activities for families and landowners in the Petitioned Area is Seneca, Kansas, where families in the Petitioned Area pay their taxes, register their vehicles, and vote. Additionally, families and students in the Petitioned Area obtain and renew their driving permits and licenses at the DMV extension at the Nemaha County Treasurer's Office in Seneca, Kansas. <u>Shopping</u>. Bern, Kansas and rest of the Petitioned Area do not have a grocery store, so most families from the Petitioned Area do grocery and other daily shopping in and around Seneca.

<u>Hospital.</u> Nemaha Valley Community Hospital is in Seneca, Kansas, and is closer to the parcels in the Petitioned Area than other area hospitals, including Sabetha Community Hospital.

<u>Family and Youth Activities.</u> The Petitioned Area is closer to centralized family and youth activities in the area's home county seat in Seneca than similar resources and activities in Sabetha. The Seneca Aquatic Center, 4-H and the Nemaha County Fair, all service the families in the Petitioned Area. Families in the Petitioned Area access Parks and Recreation activities like youth and adult basketball, baseball, softball, blastball, flag football, t-ball, soccer, and volleyball, before eventually beginning middle school and high school sports at USD 115 Nemaha Central. Additionally, many families from the Petitioned Area attend worship or other religious services in and around Seneca, including NorthRidge Church, Seneca United Methodist Church, Saints Peter and Paul Catholic Church, and New Hope Baptist Church.

<u>Catholic K-8 School.</u> Saints Peter and Paul Catholic School is a K-8 Catholic parochial school in Seneca, Kansas. Graduating eighth graders from this school attend USD 115 Nemaha Central for high school. The Petitioned Area has been home to many of these families historically, and the Petitioned Area currently has two students attending Saints Peter and Paul Catholic School in Seneca who are expected to attend USD 115 for high school.

# (10) districts that are landlocked with changing demographics that cause declining enrollment; and

As a result of school closures in Bern (2013) and Wetmore (2023), as well as other demographic and geographical factors, USD 113 (giving district) has experienced declining enrollment in the Petitioned Area as the vast majority (75%) of students in the Petitioned Area have enrolled out-of-district in USD 115. The original inclusion of the Petitioned Area in USD 113 as a result of USD 113's consolidation with former USD 488 Axtell-Bern-Summerfield in 2010 no longer reflects the enrollment trends of the region, especially after USD 113's closure of the Bern attendance centers in 2013.

Beginning in FY 2012-2013, USD 115 had 55 out-of-district students, nearly all of whom resided in the Petitioned Area. That number dropped to 41 in FY 2013-14, before steadily climbing each year. Between 2018 and 2023, USD 115 has educated an average of 84 out-of-district students, the vast majority of which have been from the Petitioned Area due to proximity and various other factors discussed herein.

USD 113 attendance centers in Axtell and Sabetha have not been feasible educational options for the vast majority of students in the Petitioned Area since 2013, a reality

that is reaffirmed and renewed every enrollment year when new families and students in the Petitioned Area choose to enroll in USD 115.

### (11) effect on students living in the area.

As a result of the variety of factors discussed above, the vast majority of families and students in the Petitioned Area have chosen to enroll in USD 115 for the past 10+ years. These enrollment trends have grown despite the complete lack of transportation funding and ad valorem revenue USD 115 derives from the Petitioned Area. The transfer of the Petitioned Area to USD 115 would have significant positive effects on the students and families in the Petitioned Area since the school district servicing most students in the area would receive more equitable funding streams to enhance and expand educational resources.

# The foregoing shall not be deemed to limit the factors which the state board of education may consider.

Additional factors in favor of land transfer include, but are not limited to: 1) ability for families in Petitioned Area to have democratic representation on school board issues in USD 115; 2) ability for families and landowners to see their ad valorem tax revenues support the school district (USD 115) educating vast majority of students in the area; 3) inclusion of Petitioned Area in USD 115 would create a more proportionate radial geographical layout of the district, giving that Seneca, Kansas is in the center of the proposed new district lines for USD 115; 4) periodic adjustment of school district lines is consistent with other governmental redistricting principles, including decennial census considerations mandated by United States and state law; 5) approval of land transfer correcting the development of chronic "out-of-district" enrollment trends in USD 115 would incentivize other districts in state to "wait and see" before petitioning for land transfer based on a singular event; 6) equitable distribution of land that reflects short- and long-term enrollment trends and landowner preferences in the Petitioned Area.

## A RESOLUTION AUTHORIZING FILING OF PETITION WITH KANSAS STATE BOARD OF EDUCATION FOR THE TRANSFER OF CERTAIN LAND FROM USD 113 (PRAIRIE HILLS) TO USD 115 (NEMAHA CENTRAL)

WHEREAS, the USD 115 Board of Education meeting in regular session on February 12, 2024 has considered the matter of petitioning the Kansas State Board of Education pursuant to K.S.A. 72-532 regarding the transfer of certain land as described on Exhibit A attached hereto ("Petitioned Area") from USD 113 (Prairie Hills) to USD 115 (Nemaha Central);

WHEREAS, representatives of USD 115 engaged USD 113 in mediation pursuant to K.S.A. 72-530 on December 5 and 6, 2023, but mediation was unsuccessful;

WHEREAS, upon due consideration, the USD 115 Board of Education has determined that it is in the best interests of its students, including the at least 78 students attending USD 115 who live in the Petitioned Area of the 104 total students living in such area, to seek the transfer of such land:

WHEREAS, having considered the chronic inequities burdening USD 115 taxpayers as a result of USD 115 educating 75% of students in the Petitioned Area, while USD 113 has annually kept 100% of the ad valorem tax revenue from the same area for the past 11 years;

WHEREAS, in November 2022, USD 115 passed a bond issue to support district infrastructure and facilities that are functioning at capacity as a result of the influx in students residing in the Petitioned Area who attend USD 115;

NOW THEREFORE, having duly reviewed and considered the Petition By Board of Education of School District No. 115 for Transfer of Territory prepared by USD 115 legal counsel, the USD 115 Board of Education now authorizes the signing and filing of such petition with accompanying exhibits by the USD 115 Board of Education President.
